



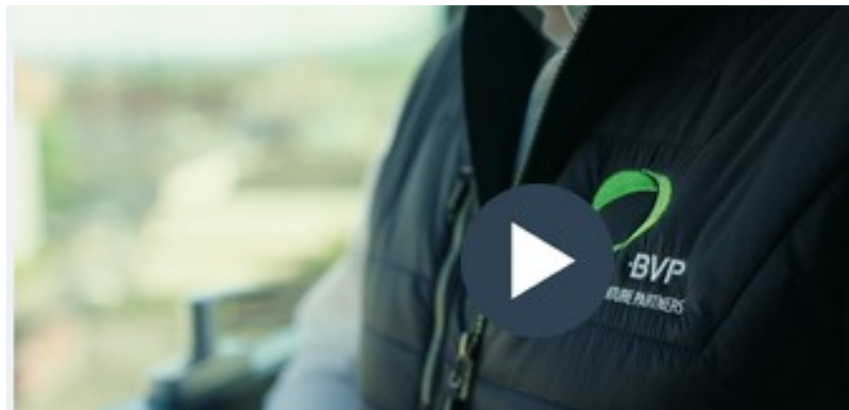

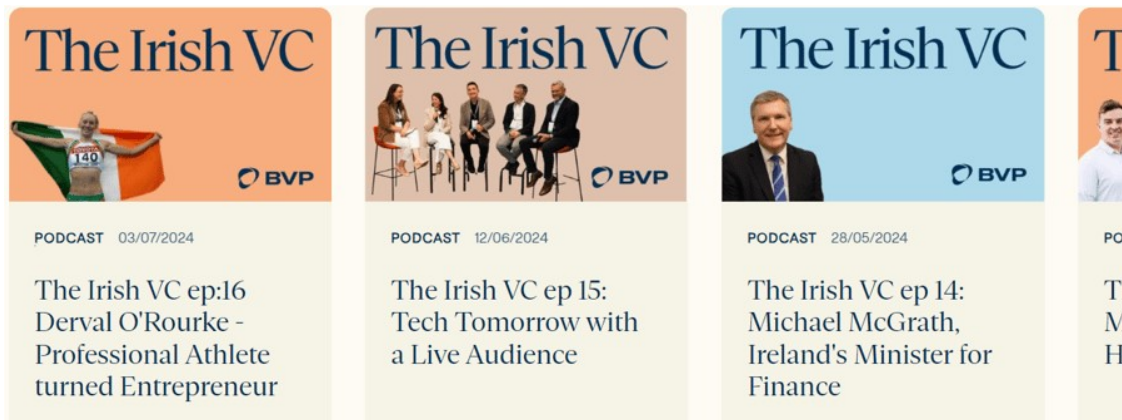

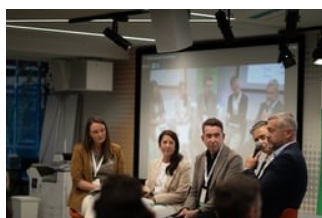
🏠 **Another milestone unlocked! 'The Irish VC' held it's first live podcast event in collaboration with Google's Startups and Networking Evening in May.**

## INVESTOR SURVEY RESULTS

 **BVP** SOME KEY INSIGHTS...
